Philosophy & Approach: My approach to supervision is based on a mutually respectful and professional relationship utilizing a developmental and integrated model of supervision, to help supervisees grow in their professional life to better serve their clients. The work is largely an exploration and development of the supervisee's own individual therapeutic orientation, counseling style, and professional identity. The general areas of focus include working to increase competence in major clinical domains of supervisee's professional behaviors: counseling skills, personal growth and awareness, case conceptualization, screening and assessment, diagnostic evaluation, treatment planning, ethical and legal issues, multicultural and diversity considerations, record keeping, and termination. not withheld if there is compelling evidence that the supervisee is impaired or unable to provide competent counseling services. In such instances, other faculty members are informed and the procedures established by the program are initiated. I carry professional liability insurance and require my supervisees to carry insurance as well.

Fees: No fees are charged if supervision occurs within the academic setting and as part of the supervisee's graduate training. For post-master's supervisees, my fee is \$100 per supervision hour.

In Case of Emergency: Supervisees are provided with my office address, email address, and personal cell phone numbers. Supervisees are asked to call me at home if an emergency occurs after hours. I also provide each supervisee with the names and phone numbers of agencies that respond to crisis situations.
